Brief Description of the Activity *

Today I moniotred team deployment and dispatch all teams with security before 8:30am. I checked 2 transit and roaming Team in THQ shabqaddar, Transit team at entery vaccinated 50 kids under 5Y while 2 chronic refusals of congenital heart disease councelled, converted and covered at this point with the support of Dr.ammanullah peadriatician. I checked 35 childrens inside THQ shabbqadar in which 31 were found vaccinated while 4 missed childrens of mc2 Shabqaddar madiha colony covered on the spot and communicated as well to mc2 shabqaddar UC. A very good roaming team observed in THQ OPD naming Hayat khan who.covered 33 childrens at the time of visit. I checked two mobile teams and took 2 HH Clusters. I.attemded ERM at UC Level chaired by Dr.Hidayat UPEC Chairman MC1 Shabqaddar in which all AlCs and support staff participated and Areawise data analysis done. I.validated Day1 missed children coverage in A3T2D1.

Issue 1 Observed *

1. I found 1 TVBCM in.A3T2D2 HH#37 child name Aneesa D/o javeed and.vaccinated the Kid infront of UCPO and PEI/EPI Coordinator. 2. I validated Day1 missed coverage of A3T2D1 and found Fake NA coverage in HH#45 child name Saad on seen and haseena on recall. 3. A3T2D1 vaccinated 81 kids on 70 doses while no AV1 and AV2 is recorded by the team. 4. Missed children recording with A3T2D2 was 27% very high. 5. HH elder did fake marking to kid by household marker to 1 child under5 in HH#80

A3T2D1. 6. AIC visited the Team of A3T2D2 2 times as a formality and didnt identified any mistake while monitor identified alot of issues.

Action 1 Taken *

1. Sweep is planned and will be conducted tommorow. 2. REDO is suggested by the monitor as 81 kids vaccinated by 70 doses in Area and UC from where we had a cVDPV Case and failed LQAS after CR 2nd round 2020. 3. On Job Training given to AIC and mobile teams. 4. Detail feedback shared in the ERM at UC level. 5. Warning will be recommended to CTC for UCPO and same will is suggested for ComNet staff and Govt staff in ERM at district level.

Way Forward *

Monitor recommended deployment of 2 or 3 DPCR moniotrs to same uc MC1 Shabqaddar from where we had a cVDPV Case 69 days back and failed LQAS 11 days back and to go through all the 3 days work, to identify gaps and to plug them accordingly.
