Respected sir,

It is stated that I have been called for explanation on account of neglect of duty i.e not reported missed houses at the boundry with district lakki and not following the instructions of supervisor.

In march campaign the missed houses were reported by third party monitors which were then covered by concerend TTM, UCMO and me.

Sir, As two UCs Ghoriwala 1and 2 are under my responsibility and in march campaign my supervision plan was in UC Ghoriwala-1 and these houses are in UC Ghoriwala-2 area4 day3 and the affected area was in the supervision of TTM.

In february campaign these houses were found missed by an external monitor and he directed me to cover these houses, so after covering the houses, I briefed him that the houses were initially covered by district lakki team but since around 6 campaign the houses were missed as lakki official says that the houses are in the jurisdiction of district bannu but our bannu DPCR couldn't agree with them and the whole DPCR including UCMO were well known about the conflict but nobody told us to own the houses. On same day in the evening meeting EPI coordinator,DHO and UCMO instructed me that don't cover the houses again also DHO said that I will send official letter to district lakki to own the disputed houses.

In UPEC meeting for the march campaign I raised the issue again but UCMO said that once you cover the houses then it means that we owned it, so don't cover that again and strictly instructed that being a UCMO I have the right of decision making and If someone from yours side have any objection then told them that talk to me.So I reported the issue from UPEC meeting through hard copy and via WhatsApp message with my concerns.

All my statement is on evidence based.

Now after the DPCR direction we have owned the houses and are included in our microplan.

At the end I want to make clear that I always preferred and will prefer what ever the task assigned by my supervisors and in future will be more careful that not give a chance to complain, but it is also humbly requested that what should I do if I face the same type of situation in future.
