Dear Dr. Irfan/Dr. Naeem,

I would like to draw your attention towards this issue of boundary dispute between UC Ghoriwala of Bannu with UC Mamakhel of Lakki Marwat. A couple of months back, there was an AFP case from a house at the boundary of Bannu and Lakki Marwat which led to identification of some missed houses. Teams form both the sides visited the area where the boundary was demarcated properly. The houses handed over to Bannu falls in the revenue territory of Bannu as well.

However, in the Feb NID, the undersigned visited the area where the said house were found missed again. It was found out that the UCMO Ghoriwala, Dr. Mehryar was reluctant to cover the houses, however, the undersigned asked the UCPO Mr. Jehanzeb to vaccinate the children on the spot irrespective of the area of jurisdiction. The UCPO despite clear instructions called the UCMO (sort of not letting me know it) to informed him about it. The UCMO forbade him to vaccinate the children. The UCPO was asked to keep covering them until the district administration solve the issue on permanent basis. He was recommended for a written warning, however, that hasn't been done yet.

Yesterday, the 3rd party monitors visited the area and found the houses missed again with no such report from the UCPO. Hence, it is recommended to take strict disciplinary action against him on priority basis.
