Dear Manasa,

With reference to the subject, please be informed that Shah Faisal Police were able to trace the suspect who hurled threats to Dr. Murtaza Talpur with the help of CDR today. He was brought to the police station for preliminary investigation.

It was later revealed that the suspect did that act out of anger as one of the female UCPO's contract whom he was having friendship was not further extended due to her poor performance in Landhi Town.

The matter was discussed with Dr. Murtaza and others relevant for further necessary action. And it was decided with consensus that police should warn the suspect, receive personal bond in writing, and release the person on the condition not to involve any such act in future. Otherwise police shall register criminal case against him as per law.

Police, then released the suspect after receiving written personal bond and complaint status is closed.

The unknown caller was threatening our PEO Dr. Murtaza Talpur asking him not to put pressure on UC level staff (probably Union Council Polio Officer (UCPO)_ Third Party personnel) otherwise he might face the dire consequences.

I am therefore, kindly requesting you to please assign SHO/SDPO Shah Faial Colony PS to kindly look into the matter to help trace the identity of the caller/persons used the caller for threatening purpose for further necessary action as per law.
