With reference to below email, an explanation was issued to UCPO Mr. Nazeem Khan on account of professional negligence. In response he mentioned that two teams were not deployed in field due to absence of AICs and he sent complete deployment report to his supervisor as the network coverage area is far away from BHU. He further added that, he always report UC level issues to UCMO and if UCMO fails to resolve the issue then he further forward it to his supervisors.

As per his supervisor, he has admitted the charges levelled against him and further he had also not reported the late coming of AICs and late deployment in his daily progress report. **(UCPO response and PEO feedback is attached)**

His response to the explanation letter is considered unsatisfactory. He has not reported late comer AICs, late deployment of field during intra campaign, fake reporting to supervisor regarding deployment of teams and submission of cluster without basic information. He is recommended for warning letter.
