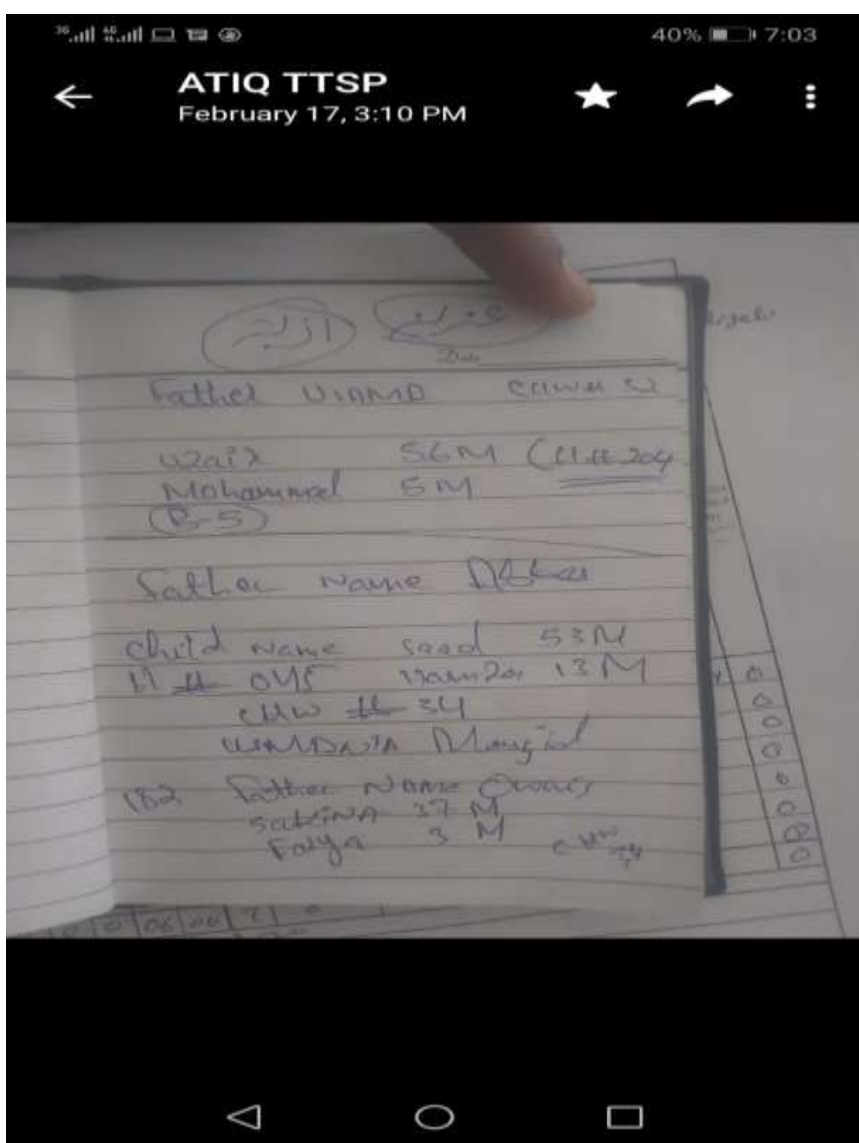

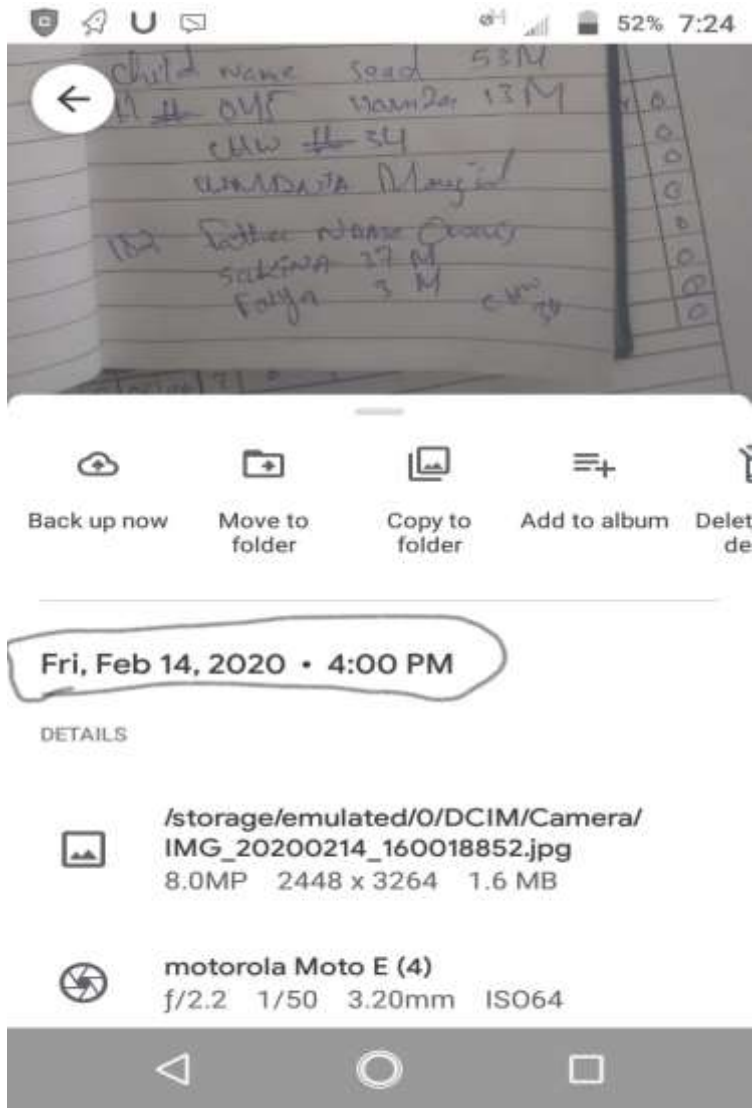

- Diary page of Rahat where he provided the Data to Atiq TTSP to take the Pic from the Diary .

- I enquired Atiq (on call)at the same time he admitted his mistake and said Rahat provided him this data when he asked him to share the data of covered refusals .
- **I asked Rahat to show me any Diary He has at the spot on 17-02-2020 ,it was exactly of the same size ,colour and a few of the pages were torn .(I couldn't find that page) .**
- In reality CHW 32 H # 204 has 4 children in total which I myself validated .(if Atiq has taken the cluster by himself he would have mentioned 4 children instead of 2 ,but as in the diary its 2 its also 2 in the cluster)
