I had received complaints about him after NID Feb 2020, that he has some personal affairs with Area supervisor of UC 4, Miss Sahiba. We also received such complaints from community as well. The DPCR team investigated the matter but we couldn't find any concrete evidences at that time.

Now I received some whatsapp messages and audio messages which Sher Muhammad sent to AS Sahiba. In these messages he used abusive language and openly threat her for dire consequences, both for her prestige and life.

I request you to please look into the matter and take necessary and urgent action.
