## **Consultancy Agreement**

THIS AGREEMENT made as of Feb 19th, 2022, at Islamabad between CHIP Training and Consulting (Pvt) Ltd (hereinafter referred to as Contractor) having its principal place of business at Islamabad and Mr. Sohail Asif (hereinafter referred to as Consultant), -- Lahore - Punjab.

IN CONSIDERATION of the promises and goods and valuable consideration the parties agree as follows:

#### 1. Position Title

- (a) The Consultant shall be designated as Provincial Scholar Task Force Member (PSTFM) for Polio Third party personnel (PTPP) as part of Polio Eradication Initiative (PEI) in Pakistan.
- (b) The consultant shall be required to work in accordance with the TORs which will form an integral part of this agreement.

### Agreement Validity

The Consultancy Agreement will be valid from Mar 1st, 2022 to Jun 30th, 2022 and will be considered discontinued if not extended expressly.

## 3. Duty Station

The Consultant shall perform his duties in - - Lahore - Punjab.

#### 4. Remuneration & Benefits

- (a) Gross stipend inclusive of communication and travel allowance of PKR. 28,380/- per month shall be paid.
- (b) The consultant will be entitled for EOBI benefits. A Contribution worth of PKR, 200/- will be deducted from the stipend of the consultant on monthly basis and be deposited to EOBI Institution along with contractor's contribution as per rules.

## Notice Clause

- (a) Both the Contractor and the Consultant at any time terminate this consultancy agreement by giving prior notice of not less than two weeks or two weeks' gross stipend in lieu of notice period.
- (b) The above clause will not be applicable where the consultancy agreement is expired either party (Consultant and Contractor) has decided not to extend it any further.
- (c) It is the absolute discretion of the Contractor to discontinue the Consultancy Agreement after it has been expired without assigning any particular reason (s).

## 6. General Terms of Consultancy

- (a) During the course of Consultancy period or subsequent to its termination, the Consultant must observe strict confidentiality regarding matters which, by their nature are to be treated as secrets or confidential and shall not be disclosed to anyone whosever
- (b) In case of any dispute/disagreement, the court/tribunals situated within the local limits of Islamabad will have the exclusive jurisdiction to adjudicate the matter.
- (c) The Contractor reserves the right to unilaterally alter/modify from time to time the terms and conditions of Consultancy Agreement and such a variation can take effect without Consultants' consent being sought.
- (d) This consultancy agreement contains the entire agreement between the parties and supersedes all prior agreements with respect to the subject matter hereof.
