





- This contract may be cancelled or withdrawn by mutual agreement of both parties by giving one day notice.
- Your salary for the duration will be **PKR 50,000** composite of basic salary, house rent, medical and utility allowance as per organization's policy. Tax will be deducted, if taxable under income tax provisions. Transportation allowance **PKR 20,000** will also be paid to manage own transport.

- In case of violation of policies, deliberate misbehavior or non-observance of a supervisor's instructions, the supervisor has the right to take immediate action in form of an oral or written warning and may request the Chief Executive Officer to suspend the duties of employee, stop salary and further to take other necessary action deemed fit to the situation.
- All reports, maps, notes, specifications, research results, statistics and other outcomes compiled or prepared by the employee or any one acting on behalf of TKF shall remain the property of TKF and cannot be passed on to anyone without obtaining the prior written approval from higher management.
- The employee shall not make use of any unpublished or confidential information made known to him / her in the course of performing his / her duties under the terms of this contract. This provision shall remain enforce even after the expiry of this contract.


