CTC team visited UC Yaqatoot- 2 on dated 07- Oct-21 and met with CBV, COMNet and PTPP staff. CTC team had individual meetings with each staff for a transparent inquiry and their written statements were recorded. (23 staff written statements are attached for reference).

Based on the written statements, it has been notified that some of the staff expressed their concerns about the behavior of the UCO and UCDO however, none of them have any issue with UCPO.

Since the people's team has already visited the UC and staff were aware about the case at the time of our visit, so, they were vigilant and reluctant to be opened up about their issues. Therefore, after having detailed discussion with District Office and Peoples team, it is suggested to issue warning letter to UCPO on unprofessional attitude.

Your kind feedback is requested before sharing it with WHO PO.

Following staff reported issues in their statements:

1) HTH Mahnoor reported issues against UCDO.

- 2) HTH Sadaf reported issues against UCO.
- 3) UCDO reported an incident about CHW Saliha on which UCPO spoke to UCDO and she apologized to CHW Saliha.
- 4) UCPO stated that UCO favors HHM Mahnoor and he has also shared it in the ERU meeting.
