Thank you for sharing the report. As per the attached report, the following is submitted for your opinion as an HR expert.

- 1. Nothing is proved against the UCPO.
- No staff member complaint about the behavior of UCPO Mr. Imran Khan to the inquiry team, their only complaint was that he was supporting UCDO Ms. Sumaira. The only exception was CHW Ms. Amna who complaint about UCPO Mr. Imran Khan's behavior, however, she could not provide any proof in support of her allegation.
- 2. None of the staff provided any evidence to support their claims of workplace abuse or harassment.
- No conclusive evidence of UCPO Mr. Imran Khan threatening the staff members was found
- 3. UCDO comes under PE and they have taken actions as per SOPs.

UCPO, being lead at the UC level, tried his best to manage issues falling under his ambit of responsibility. The same was investigated previously jointly by CTC and PE as well in which UCCO was terminated. I will suggest counselling session in this case.
