Respected Sir,

As per the complaint, received from the CBV staff of UC Lala Kaly about **Fake DDM** card and the deployment of a single person on transit point (Member Chowk) in NID May 22. On dated 02 Jun 22, I investigated the case, took feedback from the said Area Supervisor Miss. Nusrat and UCDO Kamran Khattak, as well as received the pictures of DDM cards from UCPO Mr. Nadeem Khan.

All the documents are attached herewith for your kind reference and information. I found major irregularities in DDM Cards against the Actual deployment status during NID May 22.

On Transit point Name "Member Chowk", there was a single Polio worker Mr.Siraj-Ul-Haq, under the supervision of AS Nusrat, deployed for the whole NID May 22, but ironically, UCPO filled **Fake DDM card** of Mr. Maooz Khan which was not the part, and the brother of UCPO, as per UC information, working in (Health Department) somewhere in District Peshawar.

Another card was filled with the name of Sumaira bibi against the said AS Nusrat, which in actuality, she was on duty inside BHU transit point under the supervision of AS Nighat.

The real and single Polio worker of (Member Chowk Transit point) Siraj Ul-Haq, his DDM card was filled against Nighat instead of actual AS Nusrat.

On further inquiry, Both Area Supervisors, Nusrat and Nighat completely denied their signatures on DDM Cards and considered them as **Fake Signatures**.
