This is to document my conversation with you today on a phone call.

On Sep 16, I received a phone call from Mr Aijaz UCPO stating that 02 ALSMs Hira & Sitara didn't report at TSC today. Consequently, I called Ms Rabia UCCO, and she said that as it's Friday and the last working day before the COVID campaign, I asked both of them not to report at TSC today but join the field directly and make sure school/madarsa letters distribution activity is completed. So, I counselled her that I appreciate the decision, but any activity at UC or change in the plan must be discussed with UCPO.

About an hour later, I received another phone call from Mr Aijaz UCPO that he visited ALSMs in field but they don't have missed children list that was shared by DEOC to carry in the field during the activity. So, I made a phone call to Ms Rabia UCCO that this is negligence and should not be repeated. Meanwhile, ALSMs reported to UCCO Rabia that, "they have to leave the field because of the awkward situation being created in the community as Mr Aijaz UCPO has misbehaved, shouted at them in the field also used unethical words and threatened that I'll make you people fire from the job using my linkages with the top leadership as I had done in my previous UC". Before I could intervene, decide or counsel, UCCO Rabia had brought the matter in the knowledge of DDPO Dr Kelash and according to her at the moment my number was out of reach, so she made the 2nd call to DDPO Dr Kelash.

Apart from this, Dr Muneeba IO, during her visit to Azam Basti-3, after examining the health condition of Ms Rabia UCCO, asked her to avoid field/physical activities, and this was in my knowledge also Mr Salman Arshad DCO and DEOC East.
