In continuation of below email, please be informed that we contacted Mr. Shehriyar (UCPO Andersher) on 26th September 2019 to present his original documents for verification purpose. However, he did not present his documents and switched off his mobile. On 27th September 2019, we visited LRH Hospital where he performed his duty but he was absent from duty.

Dr. Ahsan Iqbal (PEO) and Dr. Nasir (DSO) told us that he has resigned without notice period (resignation email attached).

Further, his Bachelor degree is fake, we have verbally verified from University of Peshawar.

As per SOPs we cannot accept his resignation request as investigation is in progress. So he is recommended for show cause on account of providing fake documents. If he fail to provide valid/verified documents within 48 hours from the date of issuance of show cause letter, his contract will be terminated.

Mr. Nadeem UCPO Wadpaga documents verification is in progress.
