COMPLAINT REGARDING MUHAMMAD WAQAS UNION COUNCIL POLIO OFFICER (UNION COUNCIL BAGHWANI SHUMALI).

FACTS:-

Mr. Ghulam Sarwar S/O Ghulam Rabbani, Hakim s/o Ghulam Qasim, Sona Khan s/o Ismail, Ikram Ullah s/o Ghulam Shabir and Mst: Haseena Bibi w/o Ghulam Rasool sumitted a written complaint that the Union Council Polio Officer of UC Baghwani Shumali Mr. Waqas sexually harassed the daughter in law of Mst: Haseena Bibi. They requested for strict action against the Polio Incharge.

FINDING:-

Deputy Commissioner DIKhan marked the application to the undersigned for enquiry. Both the parties were telephonically informed to be present on 20-09-019 in the office of the undersigned. On the fixed date Muhammad Waqas came to the office and a copy of allegations/application was handed over to him for reply.

The other party failed to appear in the office and two days later another person Mr. Asmatuulah came to the court alongwith a council and submitted that the applicant cannot come to record their statements because the other party is so powerful that they will attack them. On 25-09-2019 the applicant came alongwith Asmat Ullah Khan and pretended that the original applicants have come and will record their statement.

When they were asked to show their CNICs then it was revealed that both the persons were not real applicants and they were cheaters however statements were recorded from Hakim Khan and when he was cross examined then it revealed that he was a planted one and was asked to do i.e. allegation (statement attached as Annexure "A")

On the other side, Mr. Mchammad Waqas brought few notables of UC Baqwani Shumali and they submitted that written statements that the persons mentioned in the application are unknown to them and verbally told that these are take names. They also stated that the allegations levelled

against Mr. Muhammad Waqas are baseless and based on lies. They stated that the accused bears good moral character and is respectable person. (Statement attached as Annexure "B")

CONCLUSION:-

After getting statements from both the parties and hearing them it is concluded that the accused Mr. Waqas not been found guilty. He is innocent in the present case. The main cause of this application is Mr. Asmat Ullah whose wife is in Health department and Waqass has directed her to perform duty while she is not interested to perform her duties. For this reason this unanimous application was submitted to defame Mr. Muhammad Waqas and get him transferred from that area.

RECOMMENDATIONS:-

- 1. Mr. Mulammad Waqas may be exonerated from the allegation and be allowed to work in the same Union Council.
- 2. Mrs. Fouzia the wife of Asmat Ullah be transferred to a place where she had to perform duty.
