1. *Kalsoom LHW Code.03 is working in her catchment Area Gara Hayat, UC Gara Baloch from the past 20 years.*
2. *Rules are LHWs cannot work outside their catchment Areas, if necessary due to some reasons, a special permission letter is granted by LHW Coordinator after approval by DHO.*
3. *On 21<sup>ST</sup> November 2020 at Team Training of UC Gara Baloch for NID.3 2020, UCPO UC Gara Baloch Mr.Amir Abbass severely misbehaved the LHW and directed her NOT TO WORK in her Catchment Area Gara Hayat and assign her new Area Barki Abad which was also mention in Microplan of UC Gara Baloch submitted to DPCR Tank.*

4. Above stated Point No.1 and Point No.2, it is very clear that, directions to teams/LHWs to change their catchment areas due to some reasons and after approval from DHO Tank, was the responsibilities of UPEC UC Gara Baloch, not UCPO UC Gara Baloch Mr.Amir Abbass. Miss behaved to female staff is also not accepted.

**It is suggested that:** UCPO UC Gara Baloch Mr.Amir Abbass should be given a disciplinary warning, he should be called to DPCR Tank, and should be oriented by Supervisor to stuck with his TORs, monitoring of SIA, Monitoring of EOAs, Monitor R.I activities, search and report AFP Cases.

Respected sir,

It is stated that I Aamir Abbas, CNIC: 122130605659 UCPO Garra Baloch District Tank, KPK, explain myself against the explanation letter on account of insulting behavior towards colleagues which were baseless and not true about me, kalsoom LHW which is working in catchment area Garra Hayat after merging of CBV UCs into Non CBV, the government decided to involve all the health staff specially LHWs as Polio workers, On the day of team training which was held on 21st Nov 2020, During that training in front of all UC staff, the UPEC of UC Garra Baloch was discuss this matter and he want to involve another LHW to work in catchment area Garra Hayat along with Kalsoom LHW due to which her sister Sumaira which was social worker in that area have no space to work in the team and Kalsoom LHW didn't want this because of which she refuses to work with that LHW which was nominated by UPEC Mr. Azizur Rehman .just to clarify both LHWs The one nominated by UCMO and Kalsoom cover Gara Hayat and as per NEAP requirement and DHO instructions we wanted to involve more Government accountable Health care workers instead of social worker.

During all this matter I talked to all as UCPO try to solve this matter accordingly but both of them didn't listen me either UPEC nor Kalsoom, I also try to convince Kalsoom LHW that she worked with that LHW according to government policy, but she refused all the time and this all discussion do in front of all the polio UC staff which are now witness. you can inquire about allegations to any UC staff/ workers who have attended the said meeting.

After refuses to worked with that LHW and she didn't want to leave her sister, she was alleged me and UPEC Mr, Azizur Rehman that we both misbehaved with her and she also give same application in DHO Office to LHW Coordinator against Mr. Azizur Rehman after which an inquiry was conducted by the DHO Office team and result was that the complaint from Kalsoom LHW was only the allegations nothing else and she did all this because of her sister, Mr, Azizur Rehman still working as UPEC in UC Garra Baloch and that LHW Kalsoom also worked during all the campaign, district monitors didn't monitored such type of issues and the campaign was smoothly ended.

I Also want to emphasis that As a UCPO I have been working in the UC for more than 5 year and never in my career such allegations were made against me. Instead, I was given appreciation multiple times for my honest field work by district and national monitor which is been documented in multiple previous DPEC meeting minutes and can be accessed by a request to DPCR focal person/ PEO/NSTOP officer. Instead, the said worker has been given multiple Show cause and explanations from the office of DHO for not working/hindering Vaccination campaigns in previous year. That record can be accessed via LHW coordinator of the district. it is heart wrenching that I was never given a chance at district level to explain myself and the matter was inquired and escalated without giving a chance for me to clear myself.

I am thankful to Naila Nizam project manager that she gave me chance to prove and explain myself against that type of allegations.

I work in Union council with 100% female staff and I do respect my fellow colleague as a UCPO I firmly believe in One Team Under One roof and I always try to mitigate any dispute when it come while working for a national cause of Polio eradication. I know my responsibilities as being part of culturally diverse community. I respect all of my fellow colleagues and can never even think of being insensitive/bossy.
