I slipped in the Snow in our house courtyard and ultimately broke my Polio affected leg (Femur completely broken). My family shifted me to DHQ Hospital where the doctors on duty reffered me to HMC in Peshawar for operation. Now I m admitted in Ortho Ward Bed no. 4 ward number 01, and waiting for my operation that might held on comming Thursday (31th December 2020) or Monday due to COVID tests and other OT formalities.

It is pertinent to mention here that doctors will advise bed rest after my operation. However, for the time being please provide me one week medical Leave and obliged.
